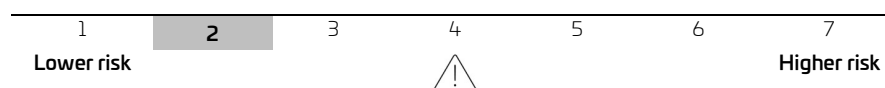

What is this product?

Type	Securities fund
Term	The Fund does not have a fixed date of expiry. The fund management company retains the right to close the fund and redeem the units. For more information, please refer to the prospectus.
Objectives	This fund is a feederfund, with the goal of tracking the performance of the masterfund, Simplicity Företagsobligationer, adjusted for the impact of being denominated in different currencies. The masterfund's objective is to achieve the highest possible return for the fund's assets, given the fund's investment focus. The fund is intended for investors who believe in investing in corporate bonds with an investment horizon of two to three years. Therefore, the fund may not be suitable for a shorter investment horizon. The fund may deviate from the performance of the masterfund depending on the proportion of the fund's assets that consist of cash and depending on the fund's annual fee. The fund is a feederfund that invests at least 85 percent of its assets in the masterfund, Simplicity Corporate Bonds, and its corresponding share classes. Up to 15 percent of the fund's assets may be invested in cash required for the management of the fund. The masterfund is a long-term bond fund that mainly invests in corporate bonds and corporate credits primarily tied to the Nordic region. Such investments not tied to the Nordic region may account for a maximum of 25 percent of the fund's value. The masterfund primarily invests in investment-grade corporate bonds but also invests in low or non-rated instruments. For investments with a low or non-rating, investments are not made in securities with a credit rating lower than B- or equivalent. The fund may use derivative instruments (OTC derivatives) to streamline management and protect the fund's assets. Investments in the masterfund's currency, SEK, will be currency hedged to EUR using derivative instruments. The share class is accumulating, which means that dividends are not normally paid out but are reinvested. Purchases and sales of fund shares can normally be made on all Swedish banking days.
Intended Investor	This fact sheet applies only to share class C. Share class C is open to investors who, under an agreement on investment services pursuant to Chapter 2, Section 1 of the Securities Market Act (2007:528) or equivalent Swedish or foreign regulation, invest in the fund and where no compensation is paid by the fund company to the person providing the investment service, and insurance companies that invest in the fund under an agreement with policyholders and where no compensation is paid to the company or insurance distributor by the fund company.

What are the risks, and what returns may I get?

Risk indicator



The summary risk indicator provides an indication of this product's level of risk in comparison to other products. It shows the probability that this product will lose value as a result of market developments. The Fund is classified as 2 out of 7, i.e. a low level of risk. This means that there is a low risk of rises and falls in the unit value of the Fund. The indicator primarily reflects rises and falls in the securities in which the fund has invested. Risks that are not reflected by the risk indicator: Counterparty risk - the risk that a counterparty fails to fulfil its commitments to the Fund, such as by not paying an agreed-upon sum or not making agreed-upon deliveries of securities. Operational risk - the risk of losses due to e.g. system failures, human error or external events. This product does not include any protection against future market developments. You may therefore lose some or all of your investment.

Return scenarios

The returns you may receive from this product are dependent on future market developments. The future development of the market is uncertain and cannot be predicted with certainty. These figures include all charges for the product itself, but do not reflect any charges that you are liable to pay to your advisor or distributor. These figures also do not reflect your personal tax situation, which may also affect the amounts that you will receive. The negative, neutral and positive scenarios reflect the worst, average and best returns that this product has generated over the last 10 years. The markets may develop in entirely different ways in the future. The stress scenario shows the returns you may receive under extreme market conditions. This scenario was applicable to one investment between 2011-2021.

What happens if Simplicity AB is unable to make payments?

By law, the Fund's assets may not be held by the fund management company. Instead, each fund must have an assigned depository to manage the possession of the Fund's assets. In the event of the fund management company's insolvency, management of the Fund is taken over by the depository. There is no compensation arrangement or guarantee scheme for investors in the Fund.

What are the charges?

The person giving you advice about or selling the product may charge you further fees. If this is the case, the person in question shall inform you about these charges and how they affect your investment.

Charges over time

The tables show the sums charged to your investment to cover various types of costs. The size of these sums is dependent on how much you invest, how long you hold the product and how your product performs. The sums shown here are based on sample figures for the investment size and various possible investment horizons.

We have applied the following assumptions: For the first year, you will get back the amount that you have invested (0% annual return). For 3 years, we have assumed that the product performs in accordance with the neutral scenario. The investment amount is 10,000 EUR.

How long should I hold the investment product, and can I withdraw money early?

Recommended investment horizon: 3 years.

The Fund does not impose a required minimum holding period, but as it invests in securities, it is suitable for a medium-long to long investment horizon. You should be prepared to retain your investment in the Fund for at least 3 years. You are normally able to sell your fund units on any banking day without extra charges.
